Prof. Gorman is also interested in a range of topics related to the management and use of information in organizations, and to information quality as exhibited in scholarly publishing in any format. He has authored many books and research papers. He is Editor of Online Information Review (Emerald) and Associate Editor, Reviews Editor and Board Member of 10 other journals. He is also active in IFLA as a corresponding member of RSCAO, committee member of CLM and the Information Literacy Section.
